Variation in Patient Safety Outcomes and the Importance of Being Informed

Announcing the Healthgrades 2013 Patient Safety Excellence Award[™] Recipients

Healthgrades has brought to light the variation in hospital quality both locally and across the nation in order to show consumers that spending time on understanding hospital performance can be a matter of life and death. Unfortunately, another area of performance disparity exists in our nation's hospitals—how well hospitals keep their patients safe by preventing medical errors and avoidable complications (see *Table 1*).

Despite the variation, consumers can arm themselves with information in order to understand what to expect from hospitals in terms of keeping patients safe and how well their local hospitals perform in this effort. The good news is there are hospitals that do a better job than other hospitals with preventing patient safety events as measured by patient safety indicators (PSIs). It is to this end, informing consumers with measurable outcomes, that Healthgrades reviews the performance of the nation's hospitals.

Healthgrades is pleased to recognize **379 hospitals** across the nation as Healthgrades Patient Safety Excellence Award[™] recipients for 2013. The distinction places this elite group of hospitals within the top 10% of all hospitals for their excellent performance in safeguarding patients from serious, potentially preventable complications during their hospital stays.

During the 2013 study period (2009-2011), Patient Safety Excellence Award hospitals showed better than expected performance in providing safety for patients in the Medicare population, as measured by objective outcomes (riskadjusted patient safety indicator rates) across 13 of the 14 most common patient safety indicators, as defined by the Agency for Healthcare Research and Quality (AHRQ). We applaud and honor these hospitals by recognizing them as Healthgrades 2013 Patient Safety Excellence AwardTM recipients (see *Table 4*).

How Hospitals Work to Improve Patient Safety

Hospitals are working harder than ever to improve communication and decrease preventable patient safety events through a variety of general initiatives, including the following:¹

Measuring, Tracking and Preventing Patient Safety Events

The first step in preventing patient safety events is to understand the extent of the problem. Hospitals around the country are now identifying hazards, measuring and tracking their rates accurately, and implementing solutions that work to prevent patient safety events.

Teamwork Training

Providing safe healthcare depends on highly trained individuals with disparate roles and responsibilities acting together in the best interests of the patient. The need for improved teamwork has led to the application of teamwork training principles, originally developed in aviation, to a variety of healthcare settings.

Creating Rapid Response Teams

Failure to recognize when a patient's condition is deteriorating is a key contributor to patient death in the hospital. The Rapid Response Team includes expertise in critical care medicine and brings that expertise to the patient's bedside.

WHY PATIENT SAFETY MATTERS

From 2009 through 2011, there were:

287,630 serious potentially preventable patient safety events among Medicare patients in U.S. hospitals.*

HOW PATIENT SAFETY EXCELLENCE AWARD RECIPIENTS MEASURE UP

When compared to hospitals performing in the bottom 5% for patient safety, Healthgrades Patient Safety Excellence Award™ recipients had three patient safety indicators showing the largest difference in observed to expected ratios.

On average, patients treated in Patient Safety Excellence Award hospitals were:

81%

less likely to experience Hip Fracture following surgery compared to hospitals ranked in the bottom 5% in the nation.*

80%

less likely to experience Pressure Sores or Bed Sores Acquired in the Hospital compared to hospitals ranked in the bottom 5% in the nation.*

70%

less likely to experience a Catheter-Related Bloodstream Infections Acquired in the Hospital compared to hospitals ranked in the bottom 5% in the nation.*

THREE INDICATORS ACCOUNT FOR OVER 66% OF ALL PATIENTSAFETY EVENTS

Three patient safety indicators accounted for 66.7% of all patient safety events during the three years analyzed:

- Deep blood clots in the lungs or legs following surgery
- Accidental puncture or laceration during a procedure
- Respiratory failure following surgery*

*Statistics are based on Healthgrades application of QI Windows® Software (version 4.4), developed by the Agency for Healthcare Research and Quality (AHRQ), to MedPAR data for years 2009 through 2011 and represent 3-year estimates for Medicare patients only.

Implementing Strategies to Improve Medication Safety

There are many opportunities for medication errors during a healthcare encounter. Hospitals are implementing numerous strategies to reduce errors, such as involving patients in their medication administration and reconciling medications when a patient is discharged—comparing the medications the patient was on prior to admission to the changes made to the medications in the hospital—to ensure there are no interactions or duplicate medications or other unintended medication errors.

Getting Aggressive About Infections

Hospital-acquired infections are a serious patient safety event and hospitals are more aggressive than ever about preventing these. Hospitals are implementing a variety of practices to prevent infections, from hand washing campaigns to clinical protocols for indwelling catheters and central lines.

Implementing Protocols to Prevent Patient Falls

Patient falls in hospitals can be very serious, especially for patients older than 65. To prevent patient falls, many hospitals have implemented fall prevention programs that include interventions: identifying patients at risk of falls, using treaded socks, placing the patient bed so that the patient may get out on his or her stronger side, and adjusting medications that may contribute to the patient's risk.

Implementing Protocols to Make Surgery Safer

Many hospitals are now using a surgical safety checklist to ensure proper patient identification, correct site of surgery, and preventive measures, such as the patient receiving antibiotics before surgery.

Patient Safety Events and Results

Healthgrades evaluated approximately 40 million Medicare hospitalizations from 2009 through 2011 and found 287,630 serious, potentially preventable patient safety events among Medicare patients in U.S. hospitals. *Table 1* shows the number of cases and events, along with the rate per 1,000 for each of 14 AHRQ-defined patient safety events (PSIs).

PATIENT SAFETY STRATEGIES HOSPITALS CAN ADOPT NOW

A panel of experts recently evaluated the effectiveness of many safety strategies. Hospitals are **strongly encouraged** to adopt the following top 10 patient safety strategies (see also 12 Patient Safety Strategies Hospitals are Encouraged to Adopt on page 3).

Top 10 Patient Safety Strategies

- 1. Preoperative checklists and anesthesia checklists to prevent operative and postoperative events
- 2. Bundles that include checklists to prevent central line-associated bloodstream infections
- 3. Interventions to reduce urinary catheter use including catheter reminders, stop orders, and nurse-initiated removal protocols
- Bundles that include head-of-bed elevation, sedation vacations, oral care with chlorhexidine, and subglottic suctioning endotracheal tubes to prevent ventilator-associated pneumonia
- 5. Hand hygiene
- 6. The do-not-use list for hazardous abbreviations
- 7. Interventions to reduce pressure ulcers
- Barrier precautions to prevent healthcareassociated infections
- 9. Real-time ultrasonography for central line placement

10. Interventions to improve prophylaxis for venous thromboembolisms

How Healthgrades Determines Patient Safety Excellence Award Recipients

Healthgrades Patient Safety Excellence Award™ recognizes the 379 hospitals out of 4,729 evaluated that have the lowest occurrences of 13 of 14 serious, potentially preventable complications and adverse events during a patient's hospital stay.

To evaluate hospital patient safety, Healthgrades uses Medicare inpatient data from the Medicare Provider Analysis and Review (MedPAR) database purchased from the Centers for Medicare and Medicaid Services (CMS). We evaluate all shortterm acute care hospitals in the MedPAR file for three years (2009 through 2011. In addition, Healthgrades uses the QI Windows® Software (version 4.4) developed by the Agency for Healthcare Research and Quality (AHRQ).

For most patient safety indicators (PSIs), the AHRQ software uses advanced statistical algorithms that can predict the number of patient safety incidents that are likely to occur at a hospital based on the types of patients treated at that hospital. This is the expected rate.

We analyze 14 AHRQ-defined PSIs, each of which represents a serious, potentially preventable complication. *Table 2* provides AHRQ's definition for each of the 14 PSIs, as well as its description used in Healthgrades reports.*

OTHER STRATEGIES TO SAFEGUARD PATIENTS

An expert panel also **encouraged** hospitals to adopt the following 12 patient safety strategies (see also *Top 10 Patient Safety Strategies* on page 2). These strategies are known to be effective and ready for hospitals to adopt now.

12 Patient Safety Strategies Hospitals are Encouraged to Adopt

- 1. Interventions to reduce falls
- 2. Clinical pharmacists to reduce adverse drug events
- 3. Documentation of patient preferences for lifesustaining treatment
- Obtaining informed consent to improve patients' understanding of the potential risks of procedures
- 5. Team training
- 6. Medication reconciliation
- 7. Practices to reduce radiation exposure from fluoroscopy and CT
- 8. Surgical outcome measurements and report cards, such as those from ACS NSQIP
- 9. Rapid response systems
- Complementary methods for detecting adverse events or medical errors to monitor for patient safety problems
- 11. Computerized provider order entry
- 12. Simulation exercises in patient safety efforts

To be eligible for the Healthgrades Patient Safety Excellence Award[™], a hospital must meet clinical quality thresholds, have zero occurrences of PSI Foreign Object Left During Surgery or Procedure, and have data on at least seven out of eight core PSIs.

- **Clinical Quality Threshold** Eligible hospitals must be in the top 80% of hospitals for clinical quality as ranked by average z-score across the conditions and procedures that Healthgrades evaluates using Medicare data. Hospitals that have patient safety data but no Healthgrades ratings, such as cancer centers, are also eligible.
- Zero Occurrences of PSI Foreign Object Left During Surgery or Procedure Eligible hospitals must not have any occurrences of the PSI: Foreign Object Left During Surgery or Procedure. A hospital is ineligible for this award if even one patient has experienced this adverse event.
- **Data for Seven of Eight Core PSIs** Healthgrades identifies a core set of eight PSIs that are serious, but potentially preventable, complications related to medical or surgical inpatient hospital care. This core set of PSIs is included in the CMS Inpatient Quality Reporting program and represents events that are most amenable to prevention when hospitals make changes. Eligible hospitals may have data for all 13 PSIs, but they must have data for at least seven of the eight core PSIs (see *Table 3*).

To recognize hospitals that provide excellent patient safety, Healthgrades:

- 1. Creates a composite patient safety z-score.
- Calculates a significance level associated with each composite patient safety z-score.
- Identifies those hospitals with a "Better than Expected" overall patient safety significance level (using a 90% confidence interval) as Patient Safety Excellence Award recipients.

SAFETY TIPS FOR PATIENTS AND CONSUMERS: HOW TO STAY SAFE IN THE HOSPITAL

Research shows that patients who are more involved with their care tend to get better results. Here are some tips that hospitals can share with patients so that they are part of the solution to staying safe:

Safety Tips for Patients & Consumers

- Speak up if you have questions or concerns. You have a right to question anyone who is involved with your care.
- Make sure that someone, such as your primary care doctor, coordinates your care. This is especially important if you have many health problems or are in the hospital.
- Make sure that all your doctors and hospital staff have your important health information including allergies to medications. Do not assume that everyone has all the information they need.
- Let everyone involved in your care know all the medication you normally take. This includes vitamins, minerals, herbs, and other dietary supplements.
- Ask a family member or friend to go with you to appointment or to check on you and review your care in the hospital.

At appointments, they can help remember what was discussed or ensure that your questions are answered.

At the hospital, they can make sure your needs are being met and notice subtle changes in your mental state and quickly call for help.

- Know that "more" tests or treatments are not always better. It is a good idea to find out why a test or treatment is needed and how it can help you. You may be better off without it.
- Protect yourself against hospital-acquired infections. Everyone who touches you or anything attached to you, such as your tubing or catheters, must have clean hands or wear clean gloves.

If you aren't sure if someone's hands or gloves are clean, just ask, "When did you last wash your hands?"

- If you have a test, do not assume that no news is good news. Ask how and when you will get the results.
- Learn about your condition and treatments by asking your doctor and nurse and by using other reliable sources.
